This course will provide education about the appropriate recognition and treatment of child physical abuse specifically in Memphis and the surrounding areas. Appropriate recognition of abuse is vital as it can often prevent additional abuse and potential escalation, and medical providers and investigators are often the first contact for children who have been abused.

- Recognize the frequency of abuse concerns and abuse diagnoses for Le Bonheur patients.
- Understand the collaborative approach that is utilized when evaluating children for physical abuse in the inpatient setting.
- Recognize the child-centered approach to investigation and medical evaluation provided by the Child Advocacy Center (CAC).
- Understand the multi-disciplinary team model utilized by the CAC for all children with concerns for maltreatment.
- Identify the various services provided by the CAC to each child who presents for evaluation.
- Understand the various departments within Department of Children's Services.
- Understand the functions of the Child Abuse Hotline and the Department of Children's Services investigation process.
